## CITIZENSHIP BY INVESTMENT

### Direct citizenship by investment

There is no "Golden Visa" or permanent residency by investment. Instead, investors can obtain direct citizenship through qualifying investment options.

### Path to Citizenship

No mandatory stay in the country is required. Citizenship remains permanent once issued (no mandatory physical residence).
